EXPAND ACCESS TO CARE

- STABILIZE THE DIRECT CARE WORKFORCE CRISIS
- EXPAND MEDICAID
- AUTHORIZE FULL PRACTICE AUTHORITY FOR ADVANCED PRACTICE REGISTERED NURSES
- STRENGTHEN TELEHEALTH
- ENSURE COMPREHENSIVE AGING PLANNING
- PROVIDE ADEQUATE RECURRING FUNDING FOR HOME & COMMUNITY-BASED SERVICES



What to Expect in the 2024 Short Legislative Session

- State budget is typically limited to budget adjustments
- Carry-over bills
- Lawmakers will typically avoid controversial issues in an election year
- Members will want to adjourn as quickly as possible to get on the campaign trail
